VI. 2019 PLAN OF ACTION

Secretary Joan Avery-Sutton lead a discussion on the plan of action for 2019 and the implementation of the movement "Working Together and Bridging the Gap". Secretary, Joan Sutton acknowledged the previous Board of Hartsfield Village and the awesome job they did in bringing stability to the finances, major repairs and the safety of the neighborhood. However, Joan Sutton wanted to provide the direction of the current Board; in which the focus will be on making the connection within the community and building healthy partnerships with other stakeholders that may share an interest in assistance HOA's. The current Board plans to work with all homeowners within Hartsfield Village to accomplish the following:

- 1. Disaster Response and Preparation
- 2. Improve Common Areas of the neighborhood
- 3. Rebuild/Restore the Website
- 4. Identify/Discuss ways to automate or outsource HOA duties, primarily the financial services. This will ensure consistency in business practices when there is a transition in new Board members.
- 5. Conduct an assessment on the needs of our neighborhood.

VII. OPEN HOA BOARD SEATS/ELECTION

President, Brendan Mulholland announced that two seats were open for election. The two positions to be filled were Brendan Mulholland, **President** and Chris Myrick, **Vice President**.

When signing in for the meeting, Members who were eligible to vote as of 02/19/2019 were given an election ballot (blank sheet of paper). Three (3) nominations were made; Joan Avery Sutton nominated Amy Christianson, Danessa Hayes nominated Sharmarie Gray, and Alan Petlz nominated Sterling Arms. In addition, proxy forms were received authorizing the Secretary, Joan Avery-Sutton to vote on behalf of eight (8) properties. All ballots were collected by President, Brendan Mulholland to tally the votes. The two (2) names chosen for the open positions were Sharmarie Gray and Amy Christianson.

VIII. GENERAL DISCUSSION

Michael Kresbach of 2242 Foster Drive had a concern about a water and drainage issue of his property. He feels that the HOA should assist in the cost to resolve the issue because of the speed bumps that were installed under the direction/authorization of the HOA. In addition, he asked Robin Wainner of the City of Tallahassee if she was aware of what department he would need to speak with to find a solution. President Brendan Mulholland stated to Mr. Kresbach that the Board would meet with him during a future Board Meeting to discuss in further detail. However, President, Brendan Mulholland informed Mr. Kresbach that the HOA was not responsible for providing financial assistance in the cost.
