## III. REPORTS:

### V. NEW BUSINESS

- A. 2019 Community Events HOA Board adopts the theme "Making a Connection and Bridging the Gap". The Board recommends hosting community events such as a Block Party, Neighborhood BBQ, Yard Sales, Ice Cream Social, etc. A committee will be created to plan out events. The following people has volunteered to serve as part of the committee: Adam Selvidge, DeAnn Peltz, Peggy Risby, and Amy Christianson. *The Board understands that funds from the HOA dues/assessments may not be used for these type expenses*.
- B. Fines and Penalties It was determined, **effective June 1, 2019**, all applicable fines/penalties will resume to be assessed if any rule or policy is violated. Notifications will be distributed to notify all residents.
- C. Assessment of Neighborhood Needs Discussion held to determine a plan to assess the needs of the neighborhood. This assessment will include disaster preparedness, repaving of Foster Dr., tree removals, additional parking areas, clean-up, sign replacement, etc. This initiative will be led by Joan Avery-Sutton in partnership with the City of Tallahassee Neighborhood Services and the Member-at-Large, Doug Morris.
- D. Next Board Meeting President, Sharmarie Gray stated that the next meeting will be held Monday, May 20, 2019, at 7:00 p.m. at Gray Memorial United Methodist Church.

# VI. GENERAL DISCUSSION:

- A. DeAnn Peltz attended the meeting to discuss concerns of both Alan Peltz and Sterling Arms. Concerns included, notification letters of drainage/run-off, fees and fines, website update/launch, replacement of signs, Board Minutes and a request of financial records for 2018 to current. *In response to Mr. Arms concerns:* 
  - 1. It was decided not to enforce fines due to the challenges in 2018 primarily due to Hurricane Michael and the Federal Shutdown. This was an effort to give homeowners and residents a relief of recovery due to these issues.
  - 2. The website is scheduled to be updated by June 1, 2019.
  - 3. An assessment of the neighborhood will be led by Joan Avery-Sutton (in partnership with City of Tallahassee Neighborhood Services to determine the needs of the community and how they can/may be accomplished.
  - 4. HOA Board Meeting Minutes, all except for two (2) month were provided for 2018. The Board did not meet in October 2018 due to the Hurricane.
  - 5. The Board (Treasurer) is currently working on a Financial packet to provide the necessary documents to respond to Mr. Arms request.
