V. UNFINISHED BUSINESS:

- A. Outsource of Financial Obligations of HOA The 2019 initiative of outsourcing financial responsibilities continues to be a work in progress. The Board has received responses from two (2) companies, Danny Hayes of Kirby Management and Lewis Association Property Management. Outsourcing financial obligations/responsibilities of the HOA is requested to eliminate fraud, lack of integrity of data and delay in reporting due to change in directors. This initiative is scheduled to be put into practice by December 2019. Alan Peltz, Treasurer is the project lead on this initiative.
- B. Quotes for Common Area and Road Maintenance The 2019 initiative of outsourcing maintenance of the common areas of Hartsfield Village is underway. Member at-Large, Sterling Arms is the Project Lead for request for services for maintenance of Hartsfield Village. Therefore, he will provide the details and negotiations for services to the board to

finalize the decisions. The Board has received the following quotes for services:

- 1. Andrews Lawn Service: Initial Clean-Up of common areas \$1,500
- 2. North Florida Asphalt, Inc.: Road Maintenance/Paving \$12,332
- 3. Benchmark: Road Maintenance/Paving \$22,636.20

VI. NEW BUSINESS

- A. The Board has the following changes in positions:
 - 1. On October 16, 2019, the Board received a resignation from Amy Christianson as Treasurer. However, **Amy Christianson** has agreed to serve as **Web Administrator**.
 - 2. On October 21, 2019, President, Sharmarie Gray appointed Alan Peltz as Interim Treasurer. Mr. Peltz has agreed to serve on the Board as Treasurer until March 2020.
 - 3. On October 21, 2019, the Board received a resignation from Doug Morris as Member-at-Large. As a result of this resignation, President Sharmarie Gray appointed **Sterling Arms as the Member-at-Large**.
 - 4. During the meeting held on October 21, 2019, Sharmarie Gray resigned as President of the HOA. This action will be finalized at the next Board meeting scheduled on November 18, 2019. Until then, Vice President Danessa Hayes will serve in the roll as President.
- B. The Board discussed implementing parking permits for residents who have medical conditions. The parking permit will allow caregivers to park overnight or during the day without violation of the parking policy. This initiative will be further discussed at the next Board meeting.
- C. The Board discussed the importance of not deleting emails. Emails must be retained to ensure that important data is not lost. It also allows current and future board members to have a point of reference of past/previous HOA related business issues and supporting documentation. The **motion** was made by Alan Peltz to retain all emails. Motion was seconded by Joan Avery-Sutton and **unanimously approved**.
