WHEREAS, on January 6, 1989, the Bylaws for Hartsfield Village III were recorded in Official Records Book 1421, Page 1541 et seq., of the public records of Leon County, Florida;

WHEREAS, at duly called meetings of the members of the Association on March 15, 2021, by a vote of a majority of a quorum of the members present in person, the Bylaws were amended as provided below.

NOW THEREFORE, in consideration of the premises, and pursuant to Article XIII, of the Bylaws, the Association certifies the following amendments to the Bylaws:

1. Article IV, Section 1 is restated and amended to read,
Number. The affairs of this Association shall be managed by a Board of at least THREE (3) directors, but no more than FIVE (5) directors.
2. Article IV, Section 2 is restated and amended to read,
Members elected to the Board shall service for a term of one year. No Board member shall serve more than three (3) consecutive years in the same office.
3. Article VI, Section 1 is restated and amended to read,
Board of Directors shall be held quarterly.
