As the end of the year approaches, there is much news to report. Invoices for the 2023 Homeowner dues will be mailed soon. Dues will remain at \$150/year despite the increased cost in so many other areas of our economy.

The City Street Takeover Project

The Board will be making one last presentation at the City Commission meeting in December, asking again for variances to the city's street takeover rules. Because we did not receive 100% of the petitions returned, the city is prohibited from completing a comprehensive summary of the project. Also, the city is obligated to place sidewalks on Nannas Loop which may cause problems for some homeowners. If we are rejected in our request, it is likely the project will not proceed.

At the September Board Meeting, homeowners requested the Board to obtain estimates for removing the 4 remaining speed bumps on Nannas Loop and the one on Jolene. The estimate should also include the patching of the pothole at Foster Drive and Hatten Smith along with a few smaller holes opening up in the neighborhood. The HOA does have a reserve for road work and to avoid a dues increase the work may need to be done in stages.
